That Jimmy R. Cisson in consideration of the sum of Thirteen Hundred Fifty and No/100 (\$1350.00)-----DOLLARS,

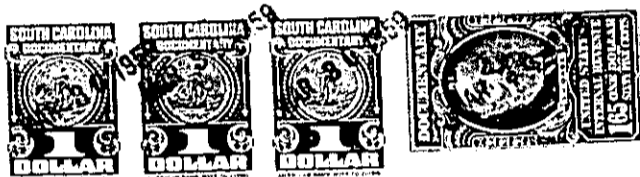
