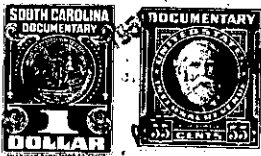

ALL that certain lot of land in Greenville County, South Carolina, known and designated as Lot 191 of Section II of Oak-Crest as shown by a plat thereof made by C. C. Jones, and recorded in the R. M. C. Office for Greenville County in plat book GG, at pages 130 and 131, and having, according to this plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Florida Avenue at the joint corner of Lots 190 and 191, and running thence with the northern side of Florida Avenue S 67-54 W 140 feet to an iron pin at the intersection of Texas Avenue; thence with the northeastern intersection of Texas Avenue and Florida Avenue, along the curve thereof, the chord of which is N 64-02 W 32.7 feet to an iron pin on the eastern side of Texas Avenue; thence with the eastern side of Texas Avenue N 14-50 W 47.1 feet to an iron pin at the corner of Lot 192; thence with the line of that lot N 70-28 E 161.7 feet to an iron pin at the corner of Lot 190; thence with the line of that lot S 16-28 E 65 feet to the point of beginning.

This is the same property conveyed to me by James O. and Frankie E. Bishop, by deed dated February 18, 1959, to be recorded.
