to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jerry H. Holcome and Doris W. Holcome their Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, just outside the corporate limits of the Town of Simpsonville, known and designated as Lot No. 5 on a Plat of the property of George W. Webb prepared by C. O. Riddle, Surveyor, May 31, 1958, and having according to said plat the following courses and distances, to-wit: Beginning at an iron pin in the Northwestern edge of an unnamed Street, joint corner with Lot No. 4, and running thence with the joint line of said Lot No. 4 N. 44-09 E. 142.9 feet to an iron pin on line of land of Sara M.
