to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

Dellie Smith Poole, her heirs and assigns forever:

All that certain piece, parcel or lot of land situated, lying and being in the State of South Carolina, County of Greenville, and in Chick Springs Township, School District 8-AC, located at the northeast corner of the intersection of "B" Street and "D" Street and being more particularly described as follows:

BEGINNING at an iron pin at the northeast corner of the intersection of "B" Street and "D" Street, and running thence along the Northeast side of "D" Street in a Northwesterly direction 60 feet more or less, to an iron pin; thence along the line of other property of T. O. Tolliver in a Northeasterly direction 90 feet, more or less, to an iron pin; thence still along the line of other property of T. O. Tolliver in a Southeasterly direction 60 feet, more or less, to an iron pin on the Northwest side of "B" Street; thence along the said line of "B" Street in a Southwesterly direction 90 feet, more or less, to the beginning corner.
