That E. J. Mullinax and Betty M. Bell in the State aforesaid, in consideration of the sum of Six Hundred Fifty and no/100 DOLLARS,

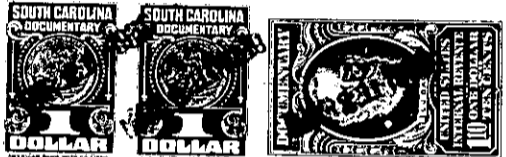

All of that lot of land in the Town of Simpsonville, County of Greenville, State of South Carolina being known as lot no. 2 in subdivision of E. J. Mullinax in accordance with plat made for E. J. Mullinax by C. O. Riddle dated May, 1958 and recorded in the R.M.C. Office for Greenville County in plat book 00 at page 153 and being more fully described in accordance with said plat, to-wit:

Beginning at an iron pin on the western side of new cut street 188.6 feet from the intersection of said new cut street and Curtiss Street and running thence N 71-30 E, 160.4 feet to an iron pin; thence N 19-14 E, 100 feet to an iron pin; thence S 71-30 E, 159.1 feet to an iron pin on edge of said new cut street; thence along said new cut street S 18-30 W, 100 feet to an iron pin being the point of beginning.
