to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

Joe M. Forrester, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, near Oneal, lying on the west side of the Rutherford Road, being a part of the same land conveyed to me by deed from Minnie Mitchell Davenport, deed recorded in the R. M. C. office for Greenville County in Deed Book 316 at page 67, and being further shown as lot No 1 on a Plat of Property of S. M. Forrester made by H. S. Brockman, Surveyor, April 13th. 1959, and having the following courses and distances, to wit:-

Beginning on a point in a dirt road that leads from the Rutherford Road to highway No. 101, joint corner of the Neacham & Few property, and runs thence with the said road, N. 89-45 E. 100 feet to a bend; thence N. 76-25 E. 100 feet to a bend; thence N. 69-27 E. 69.8 feet to a nail and cap in the center of the Rutherford Road; thence with the Rutherford road, N. 14-45 E. 100 feet to a nail and cap in the center of the said road, joint corner of Lots Nos. 1 and 2; thence with the common line of Lots Nos. 1 and 2, N. 76-45 W. 25 feet to an iron pin on the bank of the road, then continuing with the same course for a total distance of 241.3 feet to an iron pin on the Willimon line; thence with the said line, S. 14-55 W. 208 feet to the beginning corner.
