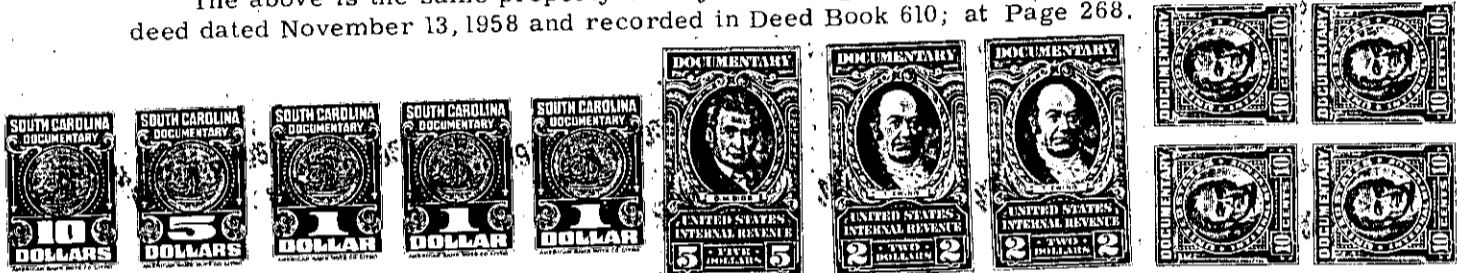
That I, Hoyt L. Walters,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Fred Massey, his Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being at Travelers Rest in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 19 of Sunny Acres as shown on plat thereon recorded in the R. M. C. Office for Greenville County in Plat Book "BB", at Page 168, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Parisview Avenue at the joint front corner of Lots Nos. 19 and 20 and running thence along the joint line of said Lots S. 29-30 E. 151.9 feet to an iron pin; thence S. 60-30 W. 75 feet to an iron pin; thence along the joint line of Lots Nos. 18 and 19 N. 29-30 W. 150.9 feet to an iron pin; thence along the southern side of Parisview Avenue N. 59-50 E. 75 feet to the point of beginning.

The above is the same property conveyed to the grantor by L. A. Moseley by his deed dated November 13, 1958 and recorded in Deed Book 610; at Page 268.
