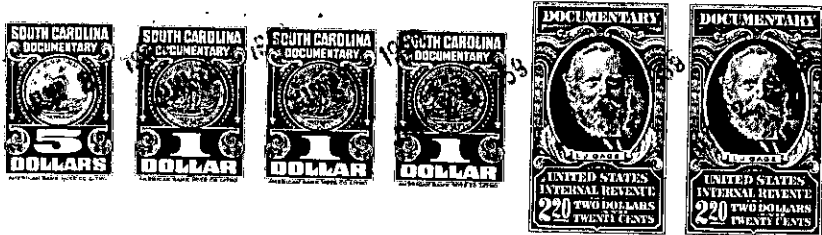
Know All Men by These Presents:

Whiteside in the State aforesaid, in consideration of the sum of \$10.00 and other valuable consideration, DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Woods Lake Holding Co., Inc., its successors and assigns,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lots 1 and 2 on plat of C. F. Putman property, made by C.O. Riddle, September 24, 1958, and described as follows:

Beginning at an iron pin at the intersection of Woods Lake Road and an unnamed road, and running thence along line of Woods Lake Road, S. 58-49 E. 181.7 feet to an iron pin at the corner of Lots 2 and 3; thence along line of Lots 2 and 3, N. 34-20 E. 214.4 feet to an iron pin at the joint rear corner of Lots 2 and 3 and in line with Lot 6; thence along line of Lot 6, N. 46-50 E. 132 feet to an iron pin at the joint corner of Lots 1 and 6, on the southeast side of unnamed road; thence along said road S. 46-05 W. 250 feet to the beginning corner.
