

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot No. 12, as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R.M.C. Office for said County and State in Plat Book "EE", at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows, to wit:

BEGINNING at an iron pin on the Southwestern side of Richbourg Road as shown on said plat at the corner common to Lots 12 and 13, and running thence S. 47-40 W. along the dividing line between Lots 12 and 13, 200 feet to an iron pin at the corner of Lot 11; thence S. 42-20 E. along the dividing line between Lots 11 and 12, 128.8 feet to an iron pin on Spring Valley Road; thence N. 64-47 E. along Spring Valley Road, 50.8 feet; thence N. 48-02 E. 76.2 feet to an iron pin; thence N. 7-40 E. 83.0 feet to an iron pin; thence N. 35-12 W. along Richbourg Road, 91.8 feet to the place of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the R.M.C.Office for said County and State in Deed Book 470, page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restrictions: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed.

This is the same property conveyed to the grantor herein by deed of Lide L.Richbourg and Lila M.Richbourg by deed recorded in the R.M.C.Office in Deed Book 574, page 297. TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises be-
