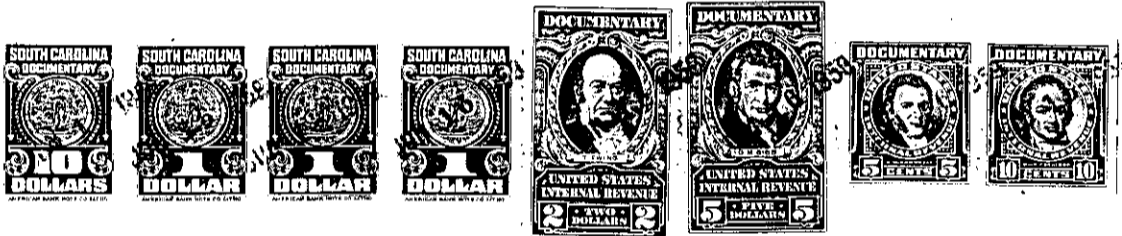

Wood in the State aforesaid, in consideration of the sum of Six Thousand, Two Hundred, Fifty-Six and 89/100 - - - - DOLLARS, and assumption of the balance due on the mortgage to Fidelity Federal Savings and Loan Association to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William H. White Jr., his heirs and assigns:

All of that lot of land in the City of Greenville, County of Greenville, State of South Carolina known as lot on the eastern side of Waccamaw Avenue being a portion of the Frank R. Nixon property on Dalton & Neves plat dated June, 1931 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Waccamaw Avenue, said pin being 210 feet north from the northwestern corner of the T. G. Godfrey lot; thence with the eastern side of Waccamaw Avenue, N 11-58 E, 70 feet to an iron pin at the corner of lot now or formerly of W. David Ridgeway; thence with Ridgeway lot; S 78-02 E, 225 feet to an iron pin at the rear corner of Ridgeway lot; thence S 11-58 W, 70 feet to an iron pin; thence N 78-02 W, 235 feet to an iron pin on the eastern side of Waccamaw Avenue. Being the same conveyed the grantor by deed book 496 at page 191.
