CHARTER BY THE SECRETARY OF STATE

EXECUTIVE DEPARTMENT

WHEREAS,

L. W. BARRON and V. H. BARRON GREENVILLE CO. S. C.

both of JUN 19 12 06 PM 1959

Greenville, S. C.

did on the 15th day of June 1959 file with the Secretary of State a written Declaration, signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is BARRON & CO.

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to purchase, own, acquire, and hold securities of every nature and kind and to sell and transfer securities of every nature and kind; to purchase, own and hold real and personal property of every nature and kind wheresoever situate and to sell, convey and transfer real and personal property of every nature and kind wheresoever situate; to carry on the business of a general investment brokerage company and to do all acts incidental and necessary to the proper and orderly operation of the corporation.

FIFTH: That the amount of the capital stock is One Thousand (\$1,000.00)-----Dollars payable upon demand of the Directors.

SIXTH: That the number of shares into which the capital stock is divided is One Thousand (1,000) of the par value of One (\$1.00)-----Dollars.

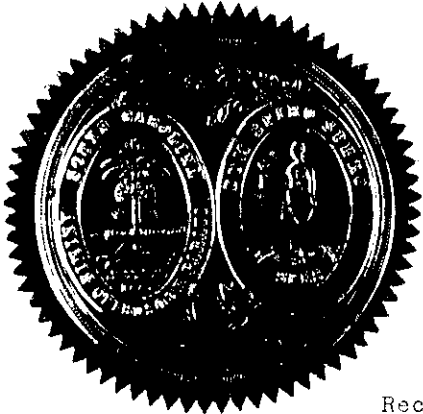
SEVENTH: That, after due notice, a meeting of the subscribers was held on the 12th day of June 19 59 at which a majority of all stock in value being present in person or by proxy, the following were elected directors: L. W. Barron and V. H. Barron

EIGHTH: That subsequently there was elected as President, L. W. Barron as Vice-President, V. H. Barron as Secretary, V. H. Barron as Treasurer, L. W. Barron

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville-News -Piedmont a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
