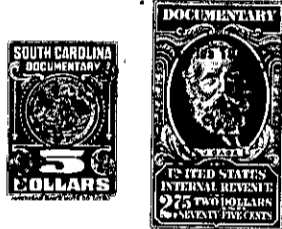
That I, WILLIAM R. TIMMONS, JR., in the State aforesaid,

acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
the said HUGH T. ANDERSON, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South
Carolina, near the City of Greenville, and being known and designated as Lot Number 110 of a
subdivision known as McSwain Gardens, Section 2, a plat of which is of record in the R. M. C.
Office for Greenville County in Plat Book LL at Page 137, and having the following metes and bounds,
to wit:

BEGINNING at a point on the Western side of Beaufort Street at the joint front corner of Lots 109 and
