Causey, his heirs and assigns Forever

All that piece, parcel or lot of land in Greenville County, State of South Carolina, on the South Saluda River containing 92.50 acres having the following metes and bounds: BEGINNING at a maple on the west side of South Saluda River at Carson bridge and running thence with the center of the South Saluda River as a line N.74-25 W.186 ft.; thence still with the said river S. 70-30 W. 113 ft thence still with said river N. 83-39 W. 163 ft.; thence still the center of the said river as the line N. 4-30 E. 555 feet; thence N. 23-53 W. 161 ft.; thence N. 50-39 W. 170 ft.; thence N. 27-10 W. 122 feet; thence N. 51-20 E. 418 ft.; thence N. 9-05 W. 296 feet; thence still with center of said river with the line N. 28-08 W. 134 ft. to the corner of the Looper property; thence with line of the Looper property N. 22-55 E. 1642 ft. to an iron pin in white oak stump hole; thence S. 46-10 E. 2522 ft.; with line of property of Oxner & McGowan to a stone corner of property now or formerly owned by W.B.
