in consideration of the sum of NINE HUNDRED FIFTY AND NO/100-----(\$950.00)-----DOLLARS,

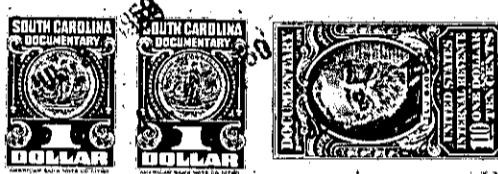
