All that certain lot of land in Paris Mountain Township, Greenville County,
State of South Carolina, and being known and designated as Lot No. 5 on plat of
property of W. S. and Ella J. Woolard made July 24, 1958, by Jones & Southerland,
Engineers, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the eastern side of Tawba Lane at corner of Lot
No. 4, and running thence with line of Lot No. 4, N. 71-17 E. 270.3 feet to an
iron pin; thence N. 15-13 W. 85.1 feet to an iron pin at corner of Lot No. 6;
