

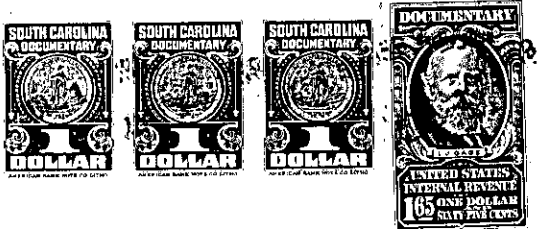
Know All Men by These Presents:

ALL That certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 7 on plat of "Pinehurst", prepared by Dalton & Neves, Engineers, August 1955, recorded in the Office of the R.M.C. for Greenville County in Plat Book PP, Page 38, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the southern side of Merrydale Lane at the joint front corner of Lots 7 and 8 and running thence along the line of said lots, S. 0-58 E. 206 feet to an iron pin in side line of Lot 4; thence turning and running along the line of Lot No. 4, N. 89-02 E. 100 feet to an iron pin, joint rear corner of Lots 7 and 5; thence along the rear lines of Lots 5 and 6, N. 0-58 W. 200 feet to an iron pin on the southern side of Merrydale Lane; thence along the southern side of Merrydale Lane, N. 87-31 W. 100.2 feet to the point of beginning.
