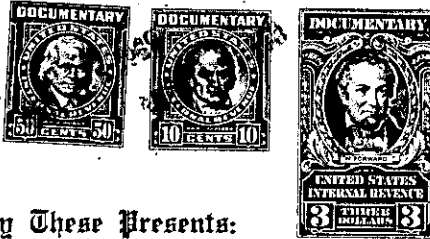

Weathers in the State aforesaid, in consideration of the sum of Five Thousand Eight Hundred Fourteen and 07/100----- DOLLARS, and assumption of mortgage described below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Kenneth L. Painter, his heirs and assigns,

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 11, plat of Pleasant Valley; which plat is recorded in the RMC Office for Greenville County in Plat Book P, page 93, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Pleasant Ridge Avenue, joint front corner Lots 10 and 11; and running thence N. 0-08 W. 160 feet to an iron pin, joint rear corner Lots 10 and 11; thence S. 89-52 W. 70 feet to an iron pin, joint rear corner Lots 11 and 12; thence S. 0-08 E. 160 feet to an iron pin on Pleasant Ridge Avenue, joint front corner Lots 11 and 12; thence along Pleasant Ridge Avenue N. 89-52 E. 70 feet to an iron pin, point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co. on which there is a balance due of \$4,035.93, said mortgage being recorded in Mortgages Volume 393, page 452.

This is the same property conveyed to the grantor by deed recorded in the RMC Office for Greenville County, S. C. in Deeds Volume 619, page 314.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

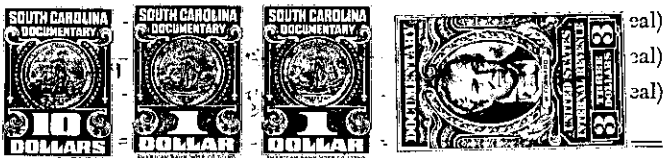
