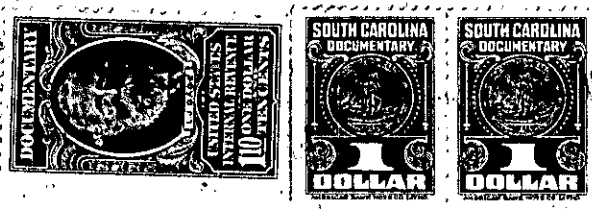

Tooke, of Greenville County in the State aforesaid, in consideration of the sum of Seven Hundred, Seventeen and 05/100 - - - (\$717.05) - - DOLLARS, and the assumption of mortgage set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), Sam David McDonald, his heirs and assigns forever:

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near Greenville, in the County of Greenville, South Carolina, and being more particularly described as Lot No. 409, Section 2, as shown on plat entitled "Sub-division for Abney Mills, Brandon Plant, Greenville, South Carolina", made by Dalton & Neves, Engineers, Greenville, S. C., February, 1959, and recorded in the Office of the R. M. C. for Greenville County in Plat Book QQ at pages 56 to 59. According to said plat the within described lot is also known as No. 11 Wilson Street and fronts thereon 66 feet. Being the same conveyed to us by Abney Mills by its deed dated May 12, 1959 and recorded in the R. M. C. office for Greenville County in Deed Vol. 627, at page 353.

This conveyance is subject to restrictions recorded in the R. M. C. office for Greenville County in Deed Book 622, at page 325.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed by the grantors on June 10, 1959 in the original sum of \$3300.00 in favor of First Federal Savings and Loan Association of Greenville, recorded in the R. M. C. office for Greenville County in Mortgage Book 792, at page 517, on which there is a balance due of \$ 3,282.95 as of this date.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
