That I, M. W. Fore in consideration of the sum of Four Hundred Ninety Five & NO/100 (\$495.00) - - - DOLLARS,

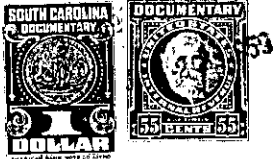
