All that piece, parcel or lot of land in Chick Springs Township Greenville County,

State of South Carolina, located about three miles Northwest from Greer on the Northwest side of a new cut dirt street about one-fourth mile off or south of State Highway No. 415 (also know as Buncombe Road) and being shown as all of lots THIRTY SEVEN(37) and THIRTY EIGHT (38) on plat Number (3), of the P.O.
