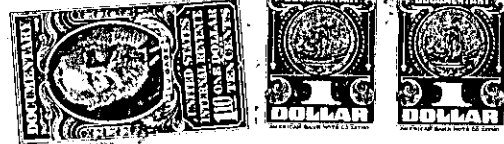

Office for Greenville County in Plat Book W, at Page 158, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Staunton Bridge Road joint front corners of Lots 5 and 6 and running thence along the line of said lots, S. 72-11 E. 161.4 feet to iron pin; thence running with rear line of Lot 11, N. 17-49 E. 85 feet to iron pin rear corner of Lot 7; thence running with line of said lot, N. 72-11 W. 161.4 feet to iron pin on Staunton Bridge Road; thence running with said Road, S. 17-49 W. 84.10 feet to iron pin at point of beginning.

NO residence to cost less than Eight Thousand Five Hundred (\$8,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.
