

Office for Greenville County, South Carolina, in Plat Book GG at page 187, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Marlboro Drive at the joint front corner of Lots Nos. 259 and 260, and running thence with the line of Lot No. 259 N. 83-16 E. 140 feet to an iron pin; thence S. 6-44 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 260 and 261; thence with the line of Lot No. 261 S. 83-16 W. 140 feet to an iron pin on the Eastern side of Marlboro Drive; thence with the Eastern side of Marlboro Drive N. 6-44 W. 80 feet to the point of beginning.
