to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Verona S. Kelley, her heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the westerly side of Heathwood Drive, near the Town of Taylors, S. C., being shown as Lot No. 65 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Heathwood Drive, joint front corner of Lots 65 and 66, and running thence S 8-12 W 61.9 feet to an iron pin at the northwesterly corner of the intersection of Heathwood Drive and Heathwood Circle; thence around said intersection on a curve, the chord of which is S 60-18 W 51 feet to an iron pin on the northerly side of Heathwood Circle; thence along the northerly side of Heathwood Circle N 69-17 W 177.8 feet to an iron pin, joint corner of Lots 65 and 67; thence along the joint line of said lots N 20-43 E 100 feet to an iron pin, joint rear corner of Lots 65 and 66; thence S 69-17 E 196.4 feet to the point of beginning.

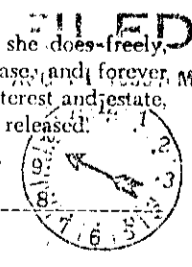
