All that certain piece, parcel or lot of land, with the buildings and  
improvements thereon, lying and being at the southerly corner of the inter-  
section of Woodbine Road and East Hillcrest Drive in the City of Greenville;  
South Carolina, being shown as Lot No. 39 on the plat of Northwood as  
recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book J,  
Pages 102-103, and having according to said plat the following metes and  
bounds, to-wit:

BEGINNING at an iron pin at the southerly corner of the intersection of Woodbine  
Road and East Hillcrest Drive and thence along the southeasterly side of Wood-  
bine Road S. 67-47 W. 55 feet to an iron pin, joint corner of Lots 39 and  
40; thence along the joint line of Lots 39 and 40 S. 45-36 E. 114.9 feet to  
an iron pin, joint corner of Lots 37, 39 and 40; thence along a common line  
with lots 37 and 38 N. 33-15 E. 100.7 feet to an iron pin on the southwesterly  
side of East Hillcrest Drive; thence along the southwesterly side of East
