to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES C. BALENTINE, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 148 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Fairfield Drive at the joint front corner of Lots 147 and 148 and running thence N 40-14 W 175 feet to a point at the joint rear corner of Lots 147 and 148; thence S 49-46 W 100 feet to a point at the joint rear corner of Lots 148 and 149; thence S 40-14 E 175 feet to a point on the Northwestern side of Fairfield Drive at the joint front corner of Lots 148 and 149; thence with the Northwestern side of Fairfield Drive N 49-46 E 100 feet to the point of beginning.
