John H. Kirkland, his heirs and assigns: All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the First Ward of the City of Greenville, on the South side of West Stone Avenue:

BEGINNING at the corner of an alley which intersects West Stone Avenue, opposite the end of Robinson Street, which alley is eleven feet and six inches wide and runs along the west side of lot owned by Thomas V. L.
