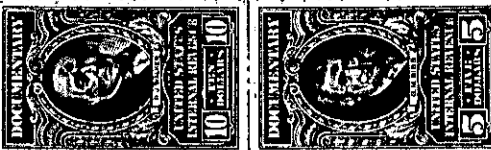

Know All Men by These Presents:

That I, Frank P. Hammond, in the State aforesaid, in consideration of the sum of Fourteen Thousand Five Hundred (\$14,500.00) - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Floyd Patrick, Sr. and Zelma B. Patrick, their heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being at the Northeast corner of the intersection of Edwards Road and Forestdale Drive, near the City of Greenville, County of Greenville, State of South Carolina and known as Lot No. 2 of Forestdale Heights as shown on a plat thereof made by R. K. Campbell, Surveyor, December, 1956, recorded in the R. M. C. Office of Greenville County, South Carolina in Plat Book "KK" at page 199, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING AT an iron pin on the Eastern side of Edwards Road, being the joint front corner of Lots 1 and 2, and running thence S. 85-29 E. 141.2 feet along the line of Lot 1 to an iron pin located on the side line of Lot 3, being the joint rear corner of Lots 1 and 2; thence running S. 4-31 W. 100 feet along the side line of Lot 3 to an iron pin located on the Northern side of Forestdale Drive, being the joint corner of Lots 2 and 3; thence running N. 85-29 W. 149.1 feet along the Northern side of Forestdale Drive to an iron pin on the Northern side of Forestdale Drive; thence running with the curve of the intersection of Forestdale Drive and Edwards Road, the cord of which is N. 31-39 W. 29.5 feet to an iron pin located on the Eastern side of Edwards Road; thence running N. 22-30 E. 80.1 ft. along the Eastern side of Edwards Road to an iron pin, being the joint front corner of Lots 1 and 2, the point of beginning.

THIS PROPERTY is subject to restrictive covenants and utilities and drainage easements of record.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

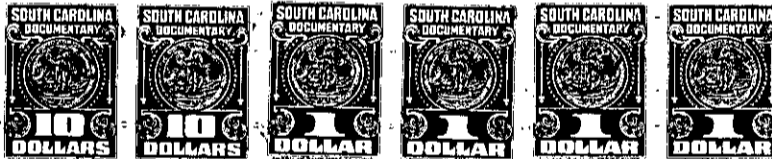
