to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ODELL SHAVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin; and being known and designated as Lot Number 75 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Fairfield Drive at the joint front corner of Lots 75 and 76 and running thence N 11-16 E 174.9 feet to a point at the joint rear corner of Lots 75 and 76; thence N 80-39 W 130.6 feet to a point on the Eastern side of an unnamed street; thence with the Eastern side of said unnamed street S 11-08 W 145.3 feet to a point; thence following the curvature of the Northeastern intersection of said unnamed street with Fairfield Drive (the chord of which is S 33-48 E 35.3 feet) to a point; thence with the Northern side of Fairfield Drive S 78-44 E 105 feet to the point of beginning.
