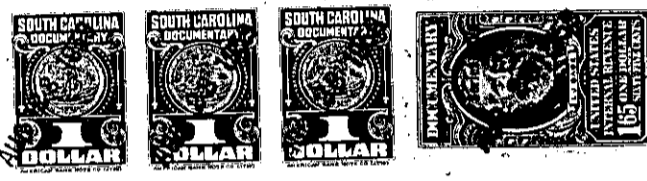

C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Cool Brook Drive at a point 241 feet northwest of the northerly corner of the intersection of Cool Brook Drive and Fleetwood Drive, said pin being the joint front corner of Lots 47 and 48, and running thence along the line of said lots N 42-15 E 157 feet to an iron pin; thence with the line of Lot 49 N 75-33 W 175 feet to an iron pin on the easterly side of Cool Brook Drive; thence along the easterly side of Cool Brook Drive the following courses and distances: S 2-49 E 84.5 feet to an iron pin; S 35-03 E 74.9 feet to an iron pin; S 49-50 E 22 feet to the point of beginning.

The above lot constitutes a part of the property conveyed to the grantor herein by the deed recorded in Deed Book 562, page 91, and this conveyance is made pursuant to the authority and powers granted the Trustee in said deed.
