FIRST: That their names and residences are as above given.

.SECOND: That the name of the proposed corporation is SECURITY MOTOR CLUB

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is—to—form and organize—a motor club and to sell membership therein; to provide the members of said club with emergency assistance, information and other benefits; to provide any and all types of benefits that the organization deems advantageous to its members. In general to carry on any other lawful business whatsoever in connection with the foregoing which is calculated directly or indirectly to promote the interest of the corporation or to enhance the value thereof.

FIFTH: That the amount of the capital stock is Two Thousand Five Hundred (\$2,500.00)--- Dollars payable in cash.

SIXTH: That the number of shares into which the capital stock is divided is One Hundred (100)
