to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. W. Strickland, his heirs and assigns:

- ALL those two lots of land in Greenville County, South Carolina known and designated as Lots #83 and #84 of Section One of Rockvale as shown by a plat thereof made by J. Mac Richardson, October, 1958, and recorded in the Greenville County RMC Office in Plat Book "QQ", at page 108, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Sandra Street at the joint corners of Lots #84 and #85 and running thence with the eastern side of Sandra Street, S. 1-58 E., 150 feet to a pin at the corner of Lot #82; thence with the line of Lot #82, N. 88-02 E., 160 feet to a pin in the rear corner of Lot #101; thence with the rear lines of Lots #101 and #100, N. 1-58 W., 150 feet to a pin at the rear corner of Lot #84; thence with the line of Lot #84, S. 88-02 W., 160 feet to the point of beginning.
