That I, J. Cleo Roper, in consideration of the sum of Twelve Thousand Two Hundred Fifty and No/100----- in the State aforesaid, DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. C. Carroll, his Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the southern side of West Gantt Circle and being known and designated as Lot No. 6 of the property of J. Cleo Roper as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "PP", at Page 133 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of West Gantt Circle at the joint front corner of Lots Nos. 6 and 7 and running thence along the joint line of said Lots, S. 15-23 E. 150 feet to an iron pin; thence N. 74-37 E. 80 feet to an iron pin; thence along the joint line of Lots Nos. 5 and 6, N. 15-23 W. 150 feet to an iron pin; thence along the southern side of West Gantt Circle, S. 74-37 W. 80 feet to the point of beginning.

The above is a portion of the property conveyed to the grantor by Ansel C. Owens by his deed dated June 30, 1958 and recorded in Deed Book 601, at Page 111.
