All those certain parcels or lots of land situated on the south side of Clarke Avenue near the City of Greer and southward therefrom, Chick Springs Township, Greenville County, State of South Carolina, and being Lots Nos. 73 and 74 of Brookhaven, property of the Dobson Estates, according to survey and plat by H.S. Brockman, Registered Surveyor, December 12, 1957, recorded in Plat Book MM, page 85, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

This is a portion of the property conveyed to the Trustees herein by the Executor and devisees of the Estates of R.A. and I.B. Dobson.

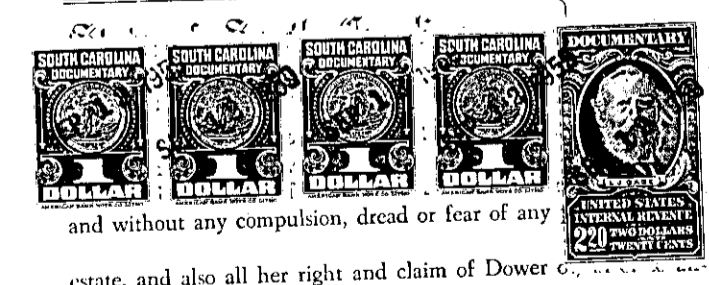
There is included herewith the right and privilege of one water tap upon completion of the water line.
