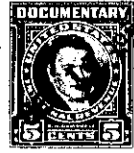

All those lots of land in the county of Greenville, state of South Carolina, known and designated as Lots Nos. 4, 5, 7, 9, 11, 13, 14, 15, 16, 17 and 18 on plat of property of J. Cleo Roper recorded in the RMC Office for Greenville County, S. C., in plat book PP page 133, reference to which plat is hereby made for a more complete description.

This is a portion of the property conveyed to the grantor by the grantee by deed dated June 10, 1958 recorded in deed volume 601 page 12, and this deed is intended to convey all the lots in said subdivision which have not heretofore been conveyed by the grantor.

This property is conveyed subject to building restrictions applicable to said subdivision recorded in the RMC Office for Greenville County in deed volume 601 page 93, and is subject to recorded easements and rights of way.
