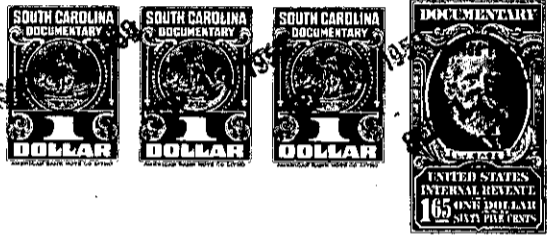
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Herbert E. Rudd and Jack E. Shaw, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #15, on the southern side of Forestwood Drive, part of Broadleaf Forest, according to a survey by Jones & Sutherland, August 1958, plat of which is recorded in the RMC Office for Greenville County, in Plat Book MM, at page 64, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of lots #15 and #14, and running thence along the line of these lots, S. 12-0 E. 145.3 feet to an iron pin; running thence S. 81-10 W. 80.2 feet to an iron pin at the joint rear corner of lots #15 and #16; running thence N. 12-0 W. 140.6 feet to an iron pin on the southern side of Forestwood Drive; running thence along the southern side of Forestwood Drive, N. 78-0 E. 80 feet to an iron pin, point of beginning.
