Greenville in the State of South Carolina, for and in consideration of the

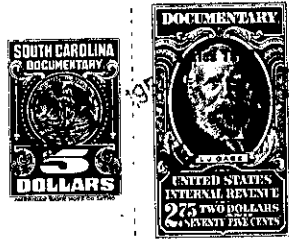
sum of Two Thousand Five Hundred and No/100 (\$2,500.00)-----dollars,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Donald E. Baltz:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 5 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Roberta Drive, the joint front corner of Lots Nos. 4 and 5, and running thence along the line of said lots N. 10-31 E. 250.9 feet to an iron pin; thence S. 85-29 E. 100.55 feet to an iron pin, the joint rear corner of Lots Nos. 5 and 6; thence following the line of said lots S. 10-31 W. 261.4 feet to an iron pin on the Northern side of Roberta Drive; thence with Roberta Drive N. 79-29 W. 100 feet to an iron pin, the point of beginning.

The foregoing lot is a portion of that conveyed to Wilkins Norwood & Company, Inc. by deed of Lucile L. Smith, et al, dated September 15, 1959, recorded in the R. M. C. Office for Greenville County, South Carolina.
