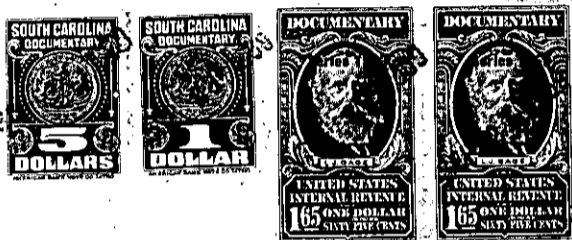
That DERBY HEIGHTS INC. in the State aforesaid, in consideration of the sum of Three Thousand and No/100----- DOLLARS,
