All that certain piece, parcel or lot of land lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the southern side of Arden Street Extension and being known and designated as Lot No. 1 on plat recorded in the R. M. C. Office for Greenville County in Plat Book Z at page 111, and having the following metes and bounds according to said plat:
