That We, D. L. Scurry and Vannoy Green Scurry, in the State of oresaid, in consideration of the sum of Thirty-six Hundred Twenty-five and no/100 - (\$3625.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mills F. Steele, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, being shown as Lots Nos. 35 and 37 of the property of H. B. Bates, plat of which is recorded in Plat Book "F" at page 32, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at the southeastern intersection of Cobb Street with Bishop Street, (now Blackwood Street), and running thence with Bishop Street, S. 55-40 E., 100 feet; S. 48-30 W., 142.5 feet; thence N. 55-40 W., 100 feet to a point on Cobb Street; thence with Cobb Street, N. 48-30 E., 142.5 feet to the point of beginning, and being a portion of the property conveyed to grantor, Vannoy Green Scurry, by deed recorded in Deed Book 316 at Page 382.

ALSO that certain other lot situate, lying and being in the City of Greenville, Greenville County, South Carolina, known and designated as Lot No. 6, according to plat made for A. C. Davis by C. M. Furman, Jr., dated February 17, 1921, and being part of the land purchased by A. C. Davis from Hillard Dawkins, said lot having a frontage of 93.2 feet on Palmer Street with a depth on one side of 91 feet and a depth on other side of 121.5 feet, and having a width on rear line of 79.5 feet. The plat above mentioned being recorded in Plat Book H, Page 419, and being identically the same lot conveyed to grantor, D. L. Scurry, by deed recorded in Deed Book 228 at page 225.
