All of that lot of land situate in Gantt Township, County of Greenville, State of South Carolina, near the City of Greenville, in that certain subdivision known as "Belle Meade", being owned by Derby Heights, Inc. shown as lot no. 130A, according to a plat made by Piedmont Engineering Service and recorded in the R.M.C. Office for Greenville County, S. C. in plat book EE at pages 116 and 117 and being more particularly described as follows:
