 in consideration of the sum of Nineteen Thousand and no/100 ----- DOLLARS,

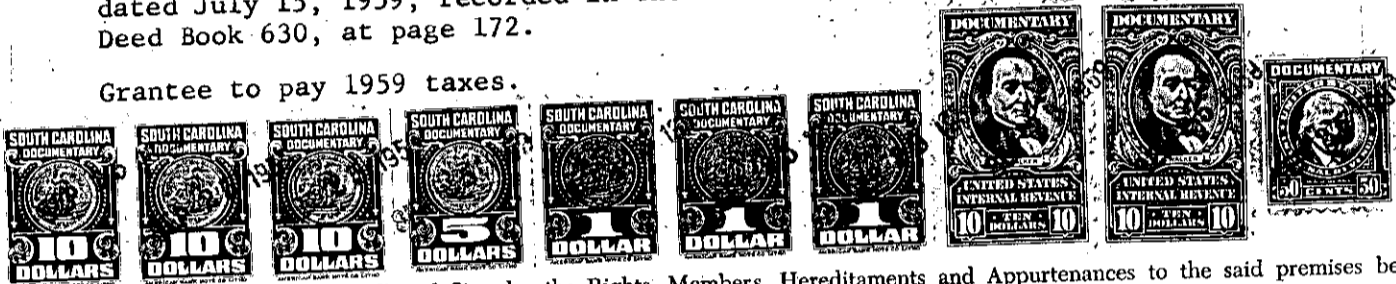

PRITCHARD, his heirs and assigns, forever:**

ALL that lot of land with the buildings and improvements thereon, situate on the Northeast side of Elizabeth Drive, near the City of Greenville, in Greenville County, S.C., being shown as Lot No. 223 on plat of property of Robert J. Edwards made by Dalton & Neves, Engineers, May 1955, recorded in the RMC Office for Greenville County, S.C., in Plat Book EE, at pages 60 and 61, and having, according to said plat, the following metes and bounds, to-wit:
