P. Medlock, his heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the Northeastern side of Miracle Drive in Gantt Township, County of Greenville, State of South Carolina, shown and designated as Lot No. 145 on Plat No. 2, Section No. 1, of Fresh Meadow Farms according to the plat made by R. K. Campbell, Surveyor, revised May 18, 1957, recorded in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "NN" at page 85, and having, according to said plat, the following mete's and bounds, to wit:

BEGINNING AT an iron pin located on the Northeastern side of Miracle Drive, being the joint corner of Lots 144 and 145 and running thence N. 44-00 W. 124.7 feet along the Northeastern side of Miracle Drive to an iron pin; thence following the curve of the Eastern side of Miracle Drive 21.9 feet, said curve having a cord running N. 4-39 W., to an iron pin located on the Southeastern side of Miracle Drive; thence running N. 42-31 E. 100 feet along the Southeastern side of Miracle Drive to an iron pin, being the joint corner of Lots 145 and 146; thence running S. 48-00 E. 147.5 feet along the line of Lot 146 to an iron pin, being the joint rear corner of Lots 144, 145 and 146; thence running S. 46-00 W. 125 feet along the line of Lot 144 to an iron pin located on the Northeastern side of Miracle Drive, being the joint corner of Lots 144 and 145, the point of beginning.

SAID LOT is conveyed subject to restrictive covenants and easements of record.
