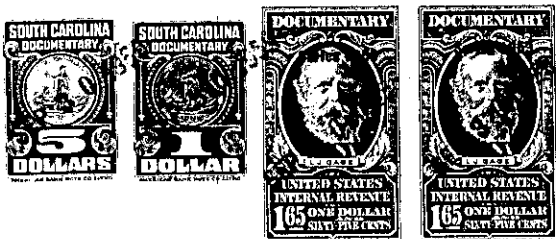
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Allen E. Vaughn, his heirs and assigns forever

All that piece, parcel or lot of land situate, lying and being on the Southern side of Berryhill Road near the city of Greenville, County of Greenville, State of South Carolina and known and designated as Lot No. 98, Section II of a Sub-division known as Lake Forest, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "EE" at Page 71 and according to said plat has the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southern side of Berryhill Road at the joint front corner of Lots Nos. 98 and 99 and running thence S 18-42 W 211 feet to an iron pin in Brushy Creek, running thence with Brushy Creek as the line, the traverse line being shown as N 89-15 E 140.6 feet to an iron pin at the joint rear corner of Lots 97 and 98, running thence N 17-07 E 153.4 feet to an iron pin on the Southern side of Berryhill Road, running thence along the Southern side of said road N 75-38 W 130 feet to an iron pin, point of beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
