TEMPLE, JR., His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 81 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ, at Pages 76-77, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Fairfield Drive at the joint front corner of Lots 80 and 81 and running thence S 11-13 W 155 feet to a point at the joint rear corner of Lots 80 and 81; thence N 78-44 W 95 feet to a point at the joint rear corner of Lots 81 and 82; thence N 11-16 E 155 feet to a point on the Southern side of Fairfield Drive at the joint front corner of Lots 81 and 82; thence with the Southern side of Fairfield Drive S 78-44 E 95 feet to the point of beginning.
