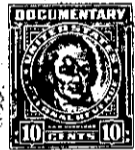
All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being located at the intersection of Darlington Avenue and Ethelridge Drive (Avenue) and designated as Lot No. 15 of the Ethel Y. Perry Property, a plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Q, at page 24, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin at the southwestern intersection of Darlington Avenue and Ethelridge Drive (Avenue), and running thence along the southwestern side of Ethelridge Drive (Avenue) S. 50-33 E. 131.2 feet to an iron pin, rear joint corner of Lots Nos. 14 and 15; thence along the joint line of said lots S. 43-0 W. 56 feet to an iron pin, rear joint corner of Lots Nos. 15 and 16; thence along the joint line of said lots N. 47-40 W. 131.1 feet to an iron pin in the line of Darlington Avenue; thence along the southeasterly side of Darlington Avenue N. 43-0 E. 50 feet to the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co., on which there is a balance due of \$3,319.83; said mortgage being recorded in Mortgages Volume 395, Page 19.
