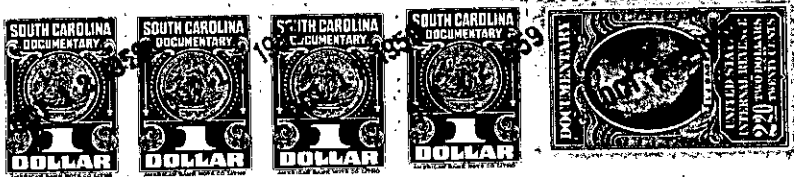
KNOW ALL MEN BY THESE PRESENTS That WILKINS NORWOOD & COMPANY, INC.

whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and
release unto J. LOUIS COWARD CONSTRUCTION COMPANY, INC.:

All that parcel or lot of land lying and being in the County of Greenville,
State of South Carolina, being designated as Lot No. 7 as shown on Plat
No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in
January, 1959, and recorded in the R. M. C. Office for Greenville County,
South Carolina, in Plat Book QQ at pages 36 and 37, and having, accord-
ing to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Roberta Drive, the joint
front corner of Lots Nos. 6 and 7, and running thence with the line of
Lot No. 7 N. 10-31 E. 271.9 feet to an iron pin; thence turning and running
S. 85-29 E. 100.55 feet to an iron pin; thence S. 10-31 W. 282.4 feet to
an iron pin on the Northern side of Roberta Drive; thence with Roberta
Drive N. 79-29 W. 100 feet to an iron pin, the point of beginning.
