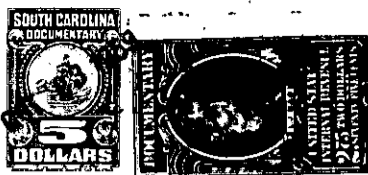

Know All Men by These Presents:

That I, Thomas J. Stafford in the State aforesaid, in consideration of the sum of Two Thousand Fifty and No/100*****(\$2,050.00) DOLLARS, and assumption of the mortgaged indebtedness herein below set forth, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Ruby Lee Murray, her heirs and assigns forever.

All those three certain lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 32, 33 and 34 of Block D, as shown on plat of Buena Vista Subdivision, recorded in the R.M.C. Office for Greenville County in Plat Book W, page 11, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Eastern side of Rose Garden Street at joint corner of Lots 9 and 32, and running thence along the rear line of Lots Nos. 9, 8, 7, 6 and 5, N 42-52 E 160 feet to iron pin at rear corner of Lot No. 10; thence with the rear line of Lots Nos. 10, 11, 12 and 13, S 47-08 E 117 feet to an iron pin; thence S 9-43 E 92.5 feet to an iron pin at rear corner of Lot No. 35; thence with the line of Lot No. 35, S 80-17 W 150 feet to iron pin on Rose Garden Street; thence with the eastern side of Rose Garden Street N 9-43 W 25 feet to bend; thence continuing with said street N 47-08 W 80 feet to the point of beginning.

As part of the consideration for this conveyance the grantee assumes the mortgage on the above described property given to C. Douglas Wilson Company by the grantor.
