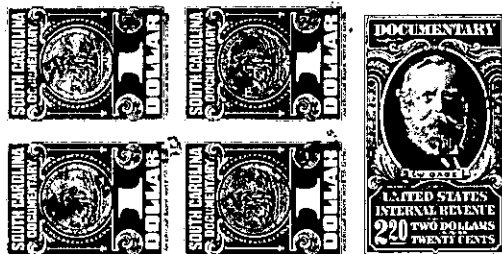

Smith, his heirs or assigns, all that piece, parcel or lot of land in the County of Greenville, State aforesaid, being known and designated as Lot No. 31 as shown on plat of property belonging to Lela S. Hodgens, said plat made by J. Coke Smith and Son, April 24, 1956, recorded in the R.M.C. office for Greenville County in Plat Book JJ at page 189 and being more particularly described according to said plat as follows:

BEGINNING at an iron pin at joint rear corner of Lot No. 30 and running along property line of Wyatt & Philpot, N. 40-04- W. 212 feet to an iron pin at the property line of J. R. Smith S. 21-15 E. 171.2 feet and S. 3-38 E 70 feet along property line of J. R. Smith to rear corner of Lot No. 28; thence along rear line of Lots Nos. 28, 29 and 30, N. 49-06 E. 227 feet to the beginning corner.

This lot of land is sold subject to the restrictions and covenants which are entered on the record in the R. M. C. office for Greenville County, South Carolina, in Deed Book 551, at Page 131, and which shall be binding upon the grantee herein.
