All that piece, parcel or lot of land situate, lying and being, in the City of Greenville, County of Greenville, State of South Carolina on the southeastern side of West Hillcrest Drive and being the southwestern portion of Lot No. 5 of Druid Hills as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "P", at Page 113 and having the following metes and bounds, to-wit:
