That L.M. BROWN in the State aforesaid, in consideration of the sum of FOUR THOUSAND ONE HUNDRED THIRTEEN AND 35/100----- DOLLARS, and assumption of mortgage described below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said CHARLES W. BOLT, HIS HEIRS AND ASSIGNS:

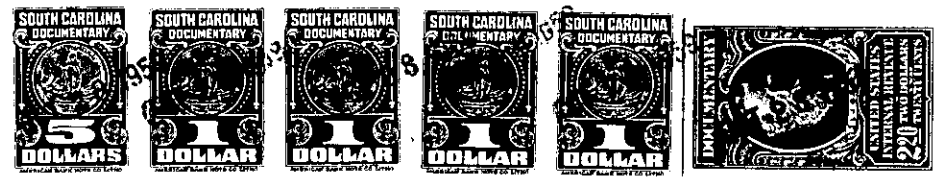
All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 13, Plat of J.E. Williams Property, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book HH, Page 141, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Berea Lane, joint front corner lots 12 and 13 and running, thence S 5-29W 170 feet to an iron pin, joint rear corner lots 12 and 13; thence N 84-31W 100 feet to an iron pin, joint rear corner lots 13 and 14; thence N 5-29E 170 feet to an iron pin on Berea Lane, joint front corner lots 13 and 14; thence along Berea Lane S 84-31E 100 feet to an iron pin at the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to First Federal Savings and Loan Association, on which there is a balance due of \$6,886.65; said mortgage being recorded in Mortgages Volume 787, Page 371.
